

**Explanation: This Resolution authorizes the Township to purchase firearm accessories for the Police Department from Lawmen Supply Company in accordance with the State of New Jersey Cooperative Purchasing Program, in an amount not to exceed \$29,758.50.**

**WHEREAS**, the Township of Springfield has a need to purchase new firearm accessories for use by the Police Department to better serve the Township's residents, business and visitors; and

**WHEREAS**, pursuant to N.J.S.A. 40A:11-12(a) and N.J.A.C. 5:34-7.29, the Township may, by resolution, purchase goods or services through the State of New Jersey Cooperative Purchasing Program for certain contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury, without the need for the Township to separately advertise for bids; and

**WHEREAS**, the State of New Jersey has awarded a contract to Lawmen Supply Company of New Jersey, Inc. of 140 Mount Holly Bypass, Suite #6, Lumberton, NJ 08048 through the New Jersey State Contract # 17-FLEET-00740 for Law Enforcement Firearms Equipment and Supplies (T0106) expiring May 14, 2026; and

**WHEREAS**, through this Resolution the Township desires to purchase 50 sights, 50 white lights, and 50 duty holsters as detailed in Quote #QT2065, which shall be subject to all the conditions applicable to the current State Contract # 17-FLEET-00740.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Springfield, County of Union, and State of New Jersey as follows:

1. The above recitals are incorporated as though set forth at length herein.
2. The Township Committee hereby authorizes the purchase of purchase 50 sights, 50 white lights, and 50 duty holsters as more fully described on the attached quote from Lawmen Supply Company of New Jersey, Inc., through the New Jersey State Contract # 17-FLEET-00740, for use by the Police Department in an amount not to exceed \$29,758.50.
3. The Police Captain and the Chief Financial Officer are authorized to effectuate this purchase.
4. The Chief Financial Officer has issued a certificate of available funds which is incorporated herein by reference, and the account numbers to be charged are T-17-56-875-000-000 in the amount of \$29,758.50.
5. This Resolution shall take effect immediately.
