

Explanation: This Resolution authorizes the Township to purchase three (3) 2026 Police Interceptor Utility vehicles for the Police Department from Winner Ford in accordance with the State of New Jersey Cooperative Purchasing Program, in an amount not to exceed \$143,235.00 (COAF).

WHEREAS, the Township of Springfield has a need to purchase three (3) 2026 Police Interceptor Utility vehicles for use by the Police Department to better serve the Township's residents, business and visitors and to help reduce operating and maintenance costs on existing vehicles; and

WHEREAS, pursuant to N.J.S.A. 40A:11-12(a) and N.J.A.C. 5:34-7.29, the Township may, by resolution, purchase goods or services through the State of New Jersey Cooperative Purchasing Program for certain contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury, without the need for the Township to separately advertise for bids; and

WHEREAS, the State of New Jersey has awarded a contract to Winner Ford , 250 Haddonfield-Berlin Road, Cherry Hill, NJ 08034 through the New Jersey State Contract # 20-FLEET-01189 for Police Pursuit and Special Service Vehicles: Gasoline, Hybrid and Plug-In Hybrid Engines (T2776) expiring June 17, 2026; and

WHEREAS, through this Resolution and properly executed contracts the Township desires to purchase three (3) 2026 Police Interceptor Utility vehicles with accessories from Winner Ford at an amount not to exceed \$143,235.00 which shall be subject to all the conditions applicable to the current State Contract # 20-FLEET-01189.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Springfield, County of Union, and State of New Jersey as follows:

1. The above recitals are incorporated as though set forth at length herein.
2. The Township Committee hereby authorizes the purchase three (3) 2026 Police Interceptor Utility vehicles more fully described on the attached quote through the New Jersey State Contract #20-FLEET-01189, for use by the Police Department in an amount not to exceed \$143,235.00
3. The Police Captain and the Chief Financial Officer are authorized to effectuate this purchase.
4. The Chief Financial Officer has issued a certificate of available funds which is incorporated herein by reference, and the account numbers to be charged are C-04-25-011-000-00D in the amount of \$143,235.00
5. This Resolution shall take effect immediately.
