

Explanation: This resolution awards a contract pursuant to public bidding law to Portofino Builders LLC., for the Resurfacing of Linden Avenue and Wabeno Avenue (NJDOT State Aid) - Contract SP-2026-01 (COAF).

WHEREAS, the Township Committee of the Township of Springfield (“Township”) did authorize and approve Capital Improvements to Township roads for the year 2026; and

WHEREAS, the Township received a New Jersey Department of Transportation State Aid Grant; and

WHEREAS, the Township of Springfield did advertise for the Linden Avenue and Wabeno Avenue resurfacing Contract SP-2026-01, for which bids were received and opened on July 8, 2026; and

WHEREAS, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq., and upon recommendation of Andrew Cangiano, PE, PP, CME, of Greenman Peterson Inc., Portofino Builders LLC. has been determined to be the lowest responsible bidder with a base bid in the amount of \$398,838.54; and

WHEREAS, the accounts to be charged are:

G-02-20-165-510-030 for \$293,025.00
C-04-25-011-000-00A for \$105,813.54

WHEREAS, the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township

of Springfield, County of Union, State of New Jersey as follows:

1. All of the above recitals are incorporated herein by reference.
2. The Township Committee hereby awards a contract to Portofino Builders LLC., 69 Irwin Street, Springfield, New Jersey 07081 in the total amount of \$398,838.54 for the provisions of goods and services in connection with the Linden Avenue and Wabeno Avenue Project, Contract SP-2026-01, as the lowest responsible bidder.

3. The Mayor and Municipal Clerk are authorized to attest and to execute an agreement with Portofino Builders LLC, for the project referenced herein above and in accordance with the Bid Specifications with all work to be completed by Linden Avenue and Wabeno Avenue., on or before December 31, 2026.
4. The contract shall be in a form approved by the Township Attorney.
5. The Township Clerk is hereby directed to publish a notice of the award of the Contract for the Service to the extent required under the Local Contracts Law within 10 days from the adoption of this Resolution.
6. This Resolution shall take effect immediately.
