

Explanation: This Resolution authorizes the purchase of firefighting turnout gear from Skylands Area Fire Equipment & Training LLC, an approved vendor under New Jersey State Contract #25-COMG-131371.

RESOLUTION NO. 2026-227**

WHEREAS, the Township of Springfield (“Township”) has a need to purchase new Firefighting Turnout Gear and related accessories; and

WHEREAS, pursuant to N.J.S.A. 40A:11-12(a) and N.J.A.C. 5:34-7.29, the Township may, by resolution, purchase goods or services through the State of New Jersey Cooperative Purchasing Program for certain contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury, without the need for the Township to separately advertise for bids; and

WHEREAS, the State of New Jersey has awarded a contract to Skylands Area Fire Equipment & Training LLC, 23 Paterson-Hamburg Turnpike, Riverdale, New Jersey 07457 through the New Jersey State Contract #25-COMG-131371, T0790 regarding Firefighter Protective Gear, Equipment and Supplies expiring March 19, 2030; and

WHEREAS, through this Resolution and properly executed contracts, and pursuant to State contract #25-COMG-131371, the Township wishes to purchase ten (10) sets of Morning Pride Turnout Gear (1 Pant and 1 Tail) from Skylands Area Fire Equipment & Training LLC in an amount not to exceed \$42,000.00, which shall be subject to all the conditions applicable to the current State Contract #25-COMG-131371.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Springfield, County of Union, State of New Jersey as follows:

1. The above recitals are incorporated as though set forth at length herein.
2. The Township Committee hereby authorizes the purchase ten (10) sets of Morning Pride Turnout Gear (1 Pant and 1 Tail) as per quotation NJ25627NJSPRI dated June 17, 2026 from Skylands Area Fire Equipment & Training LLC through the New Jersey State Contract #25-COMG-131371 in an amount not to exceed \$42,000.00.
3. The Deputy Fire Chief and the Chief Financial Officer are authorized to effectuate this purchase.
4. The Chief Financial Officer has issued a Certificate of Available Funds, which is incorporated herein by reference, and that the account to be charged is C-04-26-009-000-00D in the amount not to exceed \$42,000.00.
5. This Resolution shall take effect immediately.

TAKE NOTE that the foregoing Resolution was adopted at the Regular Meeting by the Township Committee, of the Township of Springfield, County of Union, State of New Jersey, on Tuesday, August 18, 2026.
