

Explanation: This Resolution authorizes the purchase of sights for pistols from Lawmen Supply Company as part of the approved vendor list and under New Jersey State Contract #17-FLEET-00740.

**TOWNSHIP OF SPRINGFIELD
RESOLUTION NO. 2026-230**

WHEREAS, the Township of Springfield (“Township”) has a need to purchase fifty (50) pistol sights for use by the Township’s Police Department; and

WHEREAS, pursuant to N.J.S.A. 40A:11-12(a) and N.J.A.C. 5:34-7.29, the Township may, by resolution, purchase goods or services through the State of New Jersey Cooperative Purchasing Program for certain contracts entered into on behalf of the State by the Division of Purchase and Property in the Department of the Treasury, without the need for the Township to separately advertise for bids; and

WHEREAS, the State of New Jersey has awarded a contract to Lawmen Supply Company of New Jersey, Inc., (“Lawmen”) 140 Mount Holly Bypass, Suite #6, Lumberton, New Jersey 08048 through the New Jersey State Contract #17-FLEET-00740, T0106 regarding Law Enforcement Firearms Equipment and Supplies expiring May 14, 2027; and

WHEREAS, through this Resolution and properly executed contracts, and pursuant to State contract #17-FLEET-00740, the Township wishes to purchase fifty (50) pistol sights as specified in the quote received from Lawmen dated June 29, 2026 in an amount not to exceed \$2,177.00, which shall be subject to all the conditions applicable to the current State Contract #17-FLEET-00740

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Springfield, County of Union, State of New Jersey as follows:

1. The above recitals are incorporated as though set forth at length herein.
2. The Township Committee hereby authorizes the purchase of fifty (50) pistol sights as specified in quotation QT2205 dated June 29, 2026 from Lawmen Supply Company of New Jersey, Inc. through the New Jersey State Contract #17-FLEET-00740 in an amount not to exceed \$2,177.00.
3. The Police Chief and the Chief Financial Officer are authorized to effectuate this purchase.
4. The Chief Financial Officer has issued a Certificate of Available Funds, which is incorporated herein by reference, and that the account to be charged is 6-01-25-240-000-510 in the amount not to exceed \$2,177.00
5. This Resolution shall take effect immediately.
