

Explanation: This resolution awards a contract to Denbar Construction Inc., for the Resurfacing of Fieldstone Drive (CDBG Year 52) - Contract SP-2026-03 (COAF).

WHEREAS, the Township Committee of the Township of Springfield ("Township") did authorize and approve an application for the Community Development Block Grant Year 52 for the year 2026 in the amount of \$93,000.00; and

WHEREAS, after being awarded the Community Development Block Year 52 Grant, the Township of Springfield did advertise for the Fieldstone Drive resurfacing Contract SP-2026-03, for which bids were received and opened on August 12, 2026; and

WHEREAS, pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1, et seq., and upon recommendation of Township Consulting Engineer Michael Disko, PE, PP, CME, CFM, Denbar Construction, Inc. has been determined to be the lowest responsible bidder with a base bid in the amount of \$179,667.00; with alternate bid 3 in the amount of \$9,750, and;

WHEREAS, the accounts to be charged are:

G-02-20-165-700-026 for \$93,000.00

C-04-25-011-000-00A for \$86,667.00

T-03-56-851-000-070 for \$9,750.00

WHEREAS, the Chief Financial Officer has issued a Certificate of Available Funds which is incorporated herein by reference.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Springfield, County of Union, State of New Jersey as follows:

1. All of the above recitals are incorporated herein by reference.
2. The Township Committee hereby awards a contract to Denbar Construction, Inc., 625 North Michigan Avenue, Kenilworth, New Jersey 07033 in the total amount of \$189,417.00 for the provisions of goods and services in connection with the Fieldstone Drive Project, Contract SP-2026-03, as the lowest responsible bidder.
3. The Mayor and Municipal Clerk are authorized to attest and to execute an agreement with Denbar Construction Inc., for the project referenced herein above and in accordance with the Bid Specifications with all work to be completed on or before August 30, 2027.
4. The contract shall be in a form approved by the Township Attorney.

5. The Township Clerk is hereby directed to publish a notice of the award of the Contract for the Service to the extent required under the Local Contracts Law within 10 days from the adoption of this Resolution.
6. This Resolution shall take effect immediately.
