

**Explanation: This Resolution authorizes the sale of surplus personal property by the Township via the [www.GovDeals.com](http://www.GovDeals.com) online auction website.**

**TOWNSHIP OF SPRINGFIELD  
RESOLUTION NO. 2026 -249**

**WHEREAS**, the Township of Springfield (“Township”) has surplus personal property, specifically the vehicle described on Exhibit A attached hereto (“surplus personal property”), which is no longer needed for public use by the Township; and

**WHEREAS**, the Township is a member (ID# 31106) of Sourcewell, formerly known as the National Joint Powers Alliance, a nationally recognized and accepted cooperative; and

**WHEREAS**, in an effort to obtain the best possible price for the surplus personal property, the Township desires to sell such surplus personal property by utilizing the online auction services of GovDeals, Inc., which has been awarded Sourcewell Contract #111424-GDI for online auction services for the period ending January 29, 2029; and

**WHEREAS**, the sale of the surplus personal property shall be conducted pursuant to N.J.S.A. 40A:11-36 and the guidance set forth in the Division of Local Government Services’ Local Finance Notice 2019-15.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Springfield, County of Union, State of New Jersey as follows:

1. The above recitals are incorporated as though set forth at length herein.
2. The Township Committee hereby authorizes the sale of the surplus personal property via public auction to be conducted on the [www.GovDeals.com](http://www.GovDeals.com) online auction website, pursuant to N.J.S.A. 40A:11-36 and Local Finance Notice 2019-15, for the item set forth in Exhibit A attached hereto which have been deemed hereby to be no longer needed for public use.
3. The terms and conditions of the agreement entered into with GovDeals, Inc. is available online at [www.GovDeals.com](http://www.GovDeals.com).
4. The Township Clerk shall publish an advertisement for the public sale of the surplus personal property, which shall: (i) state that the public sale is being conducted via online auction at [www.GovDeals.com](http://www.GovDeals.com); (ii) include a general description of the items being sold and the conditions of sale; (iii) set forth the time(s) and date(s) that the auction will commence and conclude; and (iv) state that the Township reserves the right to reject all bids if it determines such rejection to be in the public interest.
5. The online auction of the surplus personal property shall commence not less than seven days, nor more than fourteen days, after the date that such advertisement is published.

6. The Township reserves the right to reject all bids if it deems it to be in the public interest and will reject any bid that does not meet or exceed \$20,000.00.
7. The surplus personal property shall be sold in “as-is” condition without express or implied warranties, and the successful bidder may be required to execute a Hold Harmless and Indemnification Agreement concerning the use of the surplus personal property.
8. The appropriate Township officials are authorized to respectively execute, and attest to, all documents necessary to effectuate both the online auction of the surplus personal property and the use of GovDeals, Inc. (via [www.GovDeals.com](http://www.GovDeals.com)) for that purpose.
9. This Resolution shall take effect immediately.
